REGIONAL LABOUR MARKET MONITORING

Regional and local factors are crucial to enterprises and agencies in highly competitive and changing markets. The availability of information on the current and future state of the labour market is an important precondition for their functioning. Regional and local labour market monitoring is an ongoing practice, which generates and disseminates information that is turned into knowledge and intelligence for various actors in regional and local labour markets – policy-makers, employers and individuals. Ideally, it results in more effective decision-making and actions.

EN RLMM

The European Network on Regional Labour Market Monitoring (EN RLMM) was founded in 2006 at Goethe University Frankfurt, Germany. It seeks to develop further and diffuse the concepts and instruments used in regional labour market monitoring and to diffuse common methods for the study, research and analysis of this issue. In doing so, it brings together scientific expertise as well as experiences of practitioners at regional level. It also provides the framework to support networking between regional and local labour market observatories across Europe.

EXPERTISE

The network unites international experts with a sound background in theories, methods and application of regional and local labour market monitoring. They are available for lectures and presentations as well as for consulting or evaluation purposes.

SCIENTIFIC COMMITTEE

A group of internationally renowned scientists provides a continuous theoretical and scientific basis for the work within the EN RLMM.

PERMANENT BIG DATA WORKING GROUP

At the 10th Annual Meeting in Milan, a working group was established within the EN RLMM. It explores the various possibilities for using Big Data in labour market monitoring and the associated challenges.

THE INITIATIVE FOR NETWORKING REGIONAL AND LOCAL LABOUR MARKET OBSERVATORIES ACROSS EUROPE

There are around 550 regional and local labour market observatories located in Europe and the number is increasing. To overcome the fragmented observatory landscape and create synergies for methods of data generation and dissemination, the Initiative intends to bring together all regional and local labour market observatories in Europe in one network. The newest methods and practices in labour market monitoring are discussed during the European Day, acting as an open network for innovation and good practice exchange.
